



One Planet Annual Reporting

STEP-BY-STEP GUIDE TO REPORTING

Estimated time to report an activity is 4-7 minutes. Of course the more you report and familiarise yourself with the reporting system, the faster your reporting will become.

⇒ Go to www.oneplanetnetwork.org

⇒ Click on **MySCP**

⇒ **Login** to your MySCP

*If you do not yet have an account, please click **create an account** and continue this guide after you have created your account*

⇒ **Go to your MySCP page**

⇒ Click on the large **One Planet Reporting** button or the smaller **reporting** button in the banner – both buttons will take you to the same page



- ⇒ Welcome to your **Reporting Hub** – in here you can report activities implemented as part of your projects, or any activities contributing to the shift to SCP that are not directly linked to any of your projects.
- ⇒ Please **read the welcome message and tips** to help you get started.

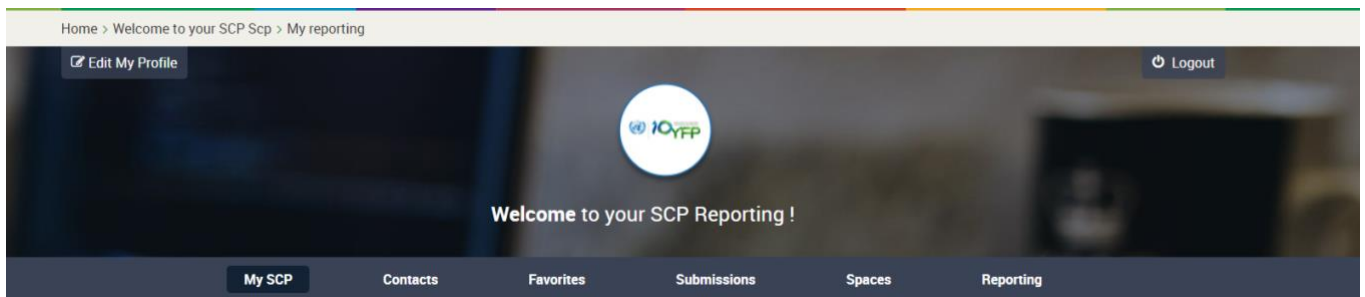
To start your reporting

Upload your project to our [database](#)

Aside from being the first step in your reporting, uploading your project helps build your portfolio and contributes to the portfolio of your programme, which increases your visibility, facilitates scaling-up and replication efforts within your programme, and further improves your reporting experience and overview.



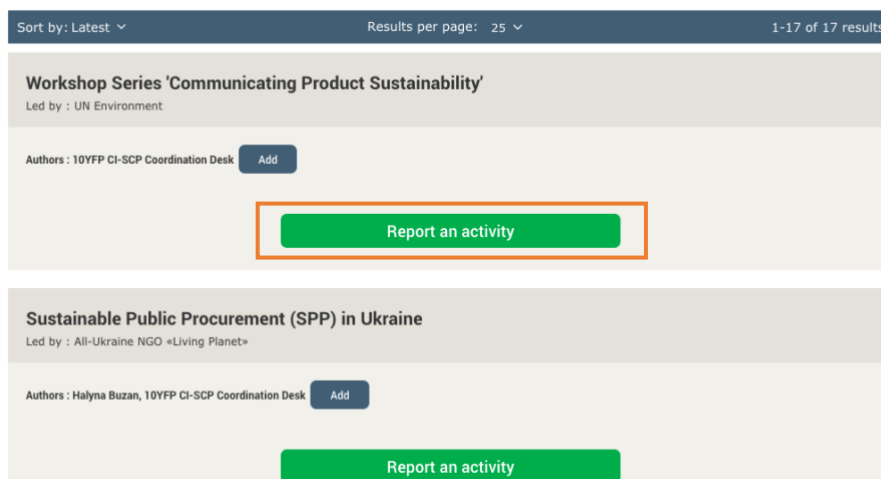

Report the activities implemented through your project

Once you have uploaded your project into the database, your return to your MySCP “One Planet Reporting” hub and report the activities of your project.

To report an activity as part of one of your projects, simply click on the “**Report an activity**” under the relevant project.





Do you have an activity that is relevant to SCP, but not related to one of your projects?

No problem! You can report on these as well. Scroll down your reporting page and click instead on **“Report on an activity not related to a project”**.
